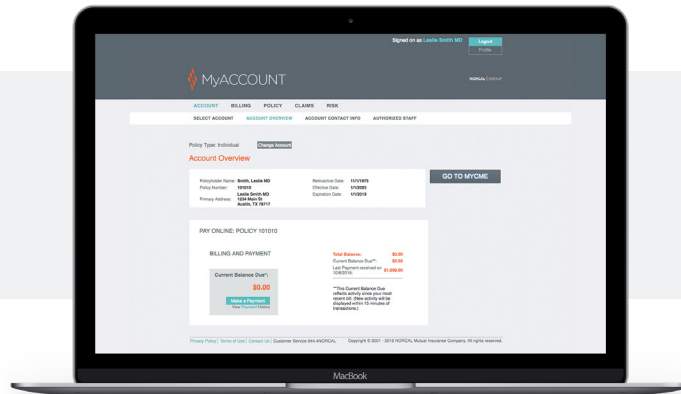

ACCESS OPTIONS

Policyholders

- ◆ **Billing Management:** Pay your bill, view your invoices and access payment history
- ◆ **Policy Portfolio:** View your policy documents and access your register of rostered insureds
- ◆ **Document Requests:** Generate credentialing letters and request account loss runs

As the policyholder, you can assign authorized staff to access your account on your behalf.

Policyholders & Insureds on a Group Policy

- ◆ **COI Generator:** On-demand certificate of insurance (COI) or proof of coverage (*instructions on reverse*)
- ◆ **Risk Resources:** Access a robust library of exclusive risk management educational material including sample forms and policies/procedures for the medical office practice
- ◆ **CME Media Center:** Claims-based learning activities featuring *Claims Rx* monthly articles and on-demand webcasts offering risk management advice on both clinical and administrative topics. Typically each activity provides an opportunity for *AMA PRA Category 1 Credit™*

COI GENERATOR: ON-DEMAND CERTIFICATE OF INSURANCE

You can print, email or fax a copy of a COI directly to a certificate holder right from MyACCOUNT under the Policy section.

To create a COI for an existing COI holder:

- ◆ Select the checkbox to the left of the corresponding insureds and COI holders.
- ◆ Press “Generate COI” and follow the prompts.
- ◆ To modify the contact information for the COI holder, press “Modify” and complete the form that will appear and follow the prompts to save and then press “Generate COI.”
- ◆ Select a method of delivery.

To create a COI for a new COI holder:

- ◆ Press “Add COI Holder” and follow the prompts on the next screen.
- ◆ You will be prompted to select the insureds, enter information for the COI holder.
- ◆ Select the method of delivery.
